### Pig Wrestling Rules

1. Teams of four (4) need to check in by 1:30 pm, August 14, 2010, announcers booth - outdoor arena
2. Team Captains are responsible for the actions of their four member team.
3. Each team has 1 minute to put their pig in the barrel.
4. Begin with 2 players on either side of the gate with one hand on the fence.
5. All players MUST wear shirt, pants, and shoes for safety reasons.
6. No player may use gloves, spikes, hooks, or any other object to help catch pig.
7. No hitting pig to stun or otherwise harm animal.
8. Pig must be taken to the barrel in the center of the ring. Barrel may not be taken to the pig.
9. Barrel must be upright and pig must be put in barrel butt first.
10. All players must raise both hands in the air to complete the match.
11. Players must stay and help unload pig out of the barrel.
12. The judge's ruling is final.



### **13. Contestants are NOT allowed in grandstands or restrooms after match.**
